

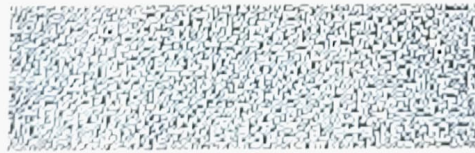

## **MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding (the "MOU") is entered into on this 1st day of September, 2025 (the "Effective Date"), by and between:

1. **INTERNATIONAL INSTITUTE OF MEDICAL SCIENCE & TECHNOLOGY COUNCIL** (hereinafter referred to as "IIMSTC"), a parastatal council established under Indian law and registered under the Ministry of Corporate Affairs, Government of India, with its registered office at Urbane Residency, 2nd Cross, Dr. Sridhar's Road, BDS Nagar, K Narayanapura, Kothanoor, Bangalore 560077, India, and corporate office at CB7, Indian Social Institute campus, Benson Road, Benson Town, Bangalore 560046, India, represented by its authorized signatory, Dr. Padma Chandra, Director of Academics;
2. **INTERNATIONAL FOUNDATION FOR SUSTAINABLE PEACE AND DEVELOPMENT (IFSPD) EUROPE** (hereinafter referred to as "IFSPD Europe"), an international institution established in 2009, with its registered office at Sofia Center, Pozitano St 26, 1000 Sofia, Bulgaria, together with its authorised representatives in India, represented by its authorized signatory, Prof. Sangeeth Varghese, President.

IIMSTC and IFSPD Europe are hereinafter collectively referred to as the "Parties" and individually as a "Party."


## RECITALS

WHEREAS, IIMSTC is an organization comprising eminent medical practitioners, scientists, educationalists, and technology professionals, collaborating with various Indian and international universities, institutes, and industry partners, and is experienced in skill development, training, and international internships aligned with national policies such as the National Education Policy and guidelines from the University Grants Commission, Government of India;

WHEREAS, IFSPD Europe is a prominent international foundation focused on sustainable peace and development, with over 60 member nations, special consulting partnership with the United Nations, and flagship initiatives like the Global Sustainability Council (Glosco), which emphasizes capacity enhancement programs based on UN Sustainable Development Goals using proprietary methodologies and case studies;

WHEREAS, the Parties recognize the mutual benefits of collaborating to develop, deliver, and promote educational and skill development programs (the "Programs"), targeted at various types of educational institutions, including but not limited to universities, colleges, institutions, secondary and senior secondary schools (collectively, the "Educational Institutions"), and corporate institutions, including but not limited to government entities, private corporates, small and medium enterprises (collectively, the "Corporate Institutions");

WHEREAS, the Programs shall include, but not be limited to, training, skilling, internships, fellowships, certification, accreditation, workshops, seminars, research collaborations, capacity building initiatives, leadership development, diplomacy training, sustainability certifications, online courses, mentorship programs, and any other tailor-made programs aligned with the Parties' expertise;
